In response to the dialogue and agreement reached with the Orchard Park/Sherwood Forest Ratepayers, I am formally acknowledging the commitment to amend the application as originally submitted. Specifically, the parameters of the amended application include:

- Brescia will continue to seek an Official Plan land use amendment from the current Low Density Residential designation to Regional Facility;
- Brescia will seek the rezoning of the northern portion of the subject site only as depicted in the attached diagram;
- The rezoning will be from **Residential (R1-10)** to **Regional Facility (RF(__))** with the following list of permitted uses:
 - Adult secondary schools;
 - Ancillary residential and/or hostels and accommodations, together with permitted uses in this zone;
 - Churches:
 - Commercial parking structures and/or lots;
 - Commercial schools;
 - Community colleges;
 - Day care centres;
 - Elementary schools;
 - Emergency care establishments;
 - Hospitals;
 - Institutional uses;
 - Libraries:
 - Nursing homes:
 - Private schools;
 - Recreational buildings;
 - Secondary schools;
 - Universities.

- Brescia agrees to the inclusion of a Special Provision to accommodate a 6.0 m wide landscaped buffer on the west side of the proposed parking lot (adjacent to 278 Ramsey Road);
- Brescia agrees to allow the parking lot site plan to follow the Administrative Site Plan review process as requested by City staff;

The remainder of the application package as submitted will remain the same. With this agreement in place, we would hope to be added to the March 26th PEC agenda in order the advance the project.




